The Oil and Gas Regulatory Authority (OGRA) invites proposals, for Pre-qualification of Suppliers of Computers. Printers & its Allied Accessories under enquiry No.10/2016, for a period of two years, as per Annex-I.

General Terms and Conditions:

- 1) The firm should be registered with Income Tax and Sales Tax Departments (Registration Numbers should be clearly mentioned and valid documentary evidence should be attached).
- 2) The firm should have a minimum of three (03) years relevant experience of similar assignment and should have proper setup and office at Islamabad/ Rawalpindi.
- The pre-qualified firms would be required to submit Security Deposit in the shape of Call Deposit/Pay Order of Rs.25,000/- (Rupees twenty five thousand only) payable at Islamabad/Rawalpindi, in favour of OGRA and in case of failure, the pre-qualification of the firm will be treated as cancelled. The security will be released to the firms within 30 days after expiry of the period of Pre-qualification. Cash/Cheque will not be accepted.
- As and when a purchase order is placed on the firm, it will be required to deposit a "Performance Bond" equivalent to 5% of the total value of the supply/purchase order payable at Islamabad. In case the firm/supplier fails to deposit performance bond within one week of the receipt of supply order, the supply order shall be treated as cancelled and the security deposit money shall be forfeited.
- 5) Payments of the bills will be subject to the deduction of government taxes/levies.
- The proposal are required to be delivered to the office of the undersigned by 11:00 a.m on August 31, 2016. The Committee will open the proposals for evaluation as per criteria given at **Annex-II** on the same date at 11:30 a.m. in the presence of the interested bidders or their authorized representatives, who may like to be present.
- OGRA, reserves the right to extend the opening date of the bids, cancel/reject any or all proposals as per PPRA Rules.
- 8) Only one authorized representative per bidder shall be allowed to attend the opening of bids.
- 9) An original and latest undertaking/affidavit on judicial paper that the firm has not been blacklisted by any Govt, Semi Govt, Automats or any State owned organization.
