S.R.O. (I)/2008.- In exercise of the powers conferred by sub-section (3) of Section 8 of Oil and Gas Regulatory Authority Ordinance, 2002 (XVII of 2002), the Authority, in super-session of its notification No.S.R.O.04(I)/2008, dated 1st January, 2008, is pleased to notify the sale prices and minimum charges specified in schedule below, for the purposes of the said Ordinance, in respect of natural gas sold by the following companies to various categories of their retail consumers with effect from 1st July, 2008, namely:-

I. Domestic Consumers:

- (i) For domestic consumers, including residential colonies, mosques, churches, temples, madrassas, other religious places and hostels attached thereto, Government and semi-Government offices and hospitals, Government guest houses, Armed Forces messes, langars, universities, colleges, schools and Private Educational Institutions, orphanages and other charitable institutions.

The lower price benefit of only two preceding slabs would be available to consumer falling in any particular slab.

- (ii) For hostels and residential colonies to whom gas is supplied through bulk meters.

Sale price: Rs. 149.40 per MMBTU

Minimum charge: Rs. 503.77 per month

II. Commercial Consumers:

All establishments registered as commercial units with local authorities or dealing in consumer items for direct commercial sale like cafes, bakeries, milk-shops, tea stalls, canteens, barber shops, laundries, places of entertainment like cinemas, clubs, theaters and private offices, clinics, maternity homes, etc.

Sale price: Rs. 370.80 per MMBTU

Minimum charge: Rs. 1,750.44 per month

III. Special Commercial (Roti Tandoors)

Upto 300 cubic meters, billing is to be done in accordance with domestic sector mechanism whereas those consuming above 300 cubic meters will be billed as normal commercial consumers.

V. Industrial Consumers:

All consumers engaged in the processing of industrial raw material into value added finished products irrespective of the volume of gas consumed including hotel industry but excluding such industries for which a separate rate has been prescribed.

Sale price: Rs. 329.54 per MMBTU

Minimum charge: Rs. 11,111.89 per month

VI. Compressed Natural Gas (CNG) Stations:

Sale price: Rs. 388.32 per MMBTU

Minimum charge: Rs. 13,094.08 per month

VII. Cement Industry:

Sale price: Rs. 428.89 per MMBTU

Minimum charge: Rs. 14,461.92 per month

VIII. Fertilizer Factories:
