General Terms and Conditions:

1. The motor vehicles will be sold on **“as is where is”** basis.
2. The bidder will be required to submit a pay order for an amount equal to 2% of the total value of bid as earnest money in favour of OGRA, payable at Islamabad.
3. The vehicle will be sold to the highest evaluated bidder.
4. The successful bidder will be required to pay an amount equal to 20% of the bid money in cash or through pay order, on the next working day before the close of the working hours. In case of failure to deposit the said amount with OGRA, earnest money will be forfeited in favour of OGRA.
5. On acceptance of the bid, the bidder will be required to pay the balance amount within seven (07) days in the form of pay order in favour of OGRA, payable at any bank in Islamabad and remove the vehicle immediately at his/her own risk & cost. In case of failure in depositing the balance amount within prescribe time limit of seven days, earnest money as well as 20% advance of the successful bidder shall be forfeited in favour of OGRA.
6. The bids are required to be delivered to the office of the undersigned on or before October 23, 2018 by 11:00 a.m. The Disposal Committee of OGRA will open the bids on the same day at 11:30 a.m in the presence of the bidders or their authorized representative who may like to be present.
7. Interested parties must bring their original or attested photocopy of CNIC with them.

8. The successful bidder will be required to pay existing/implemented/additional percentage of Income Tax imposed by Government from time to time.
9. 2% earnest money will be refunded to the unsuccessful bidders within five (05) working days of the bidding date.
10. The OGRA employees and their families will not be entitled to participate in the bidding process.
