TENDER DOCUMENTS

The Oil and Gas Regulatory Authority (OGRA) hereby invites sealed bids, for provision of group life insurance coverage for OGRA's employees (Employees of Head Office, Islamabad and its Regional Offices Lahore, Karachi, Peshawar and Quetta) under Tender Enquiry No.01 of 2020.

General Terms and Conditions:

- 1). The bidder should submit a single package containing two separate sealed envelopes. One envelope should contain the **Technical/Pre-qualification Proposal (Annex-I)** and the other envelope should contain the **Financial Proposal, (Annex-II)**, both showing the tender enquiry No.01 of 2020 and marked as "TECHNICAL/PRE-QUALIFICATION PROPOSAL" and "FINANCIAL PROPOSAL".
- 2). The firm should be registered with Income Tax and SECP (Registration Number should be clearly mentioned and valid documentary evidence be attached).
- 3). The firm should have a minimum of ten (10) years experience of similar assignments and should have a proper setup/office at Islamabad/Rawalpindi.
- 4). The bidder shall be required to deposit Bid Security in shape of **call deposit** in favour of OGRA payable at Islamabad equal to 3% of total bid value along with Financial Proposal. Cash/Cheque will not be accepted.
- 5). The bidder shall submit an original and latest undertaking/affidavit on judicial paper that the firm has not been blacklisted by any Government, Semi Government, Autonomous or any State Owned Organization.
- 6). The detailed Scope of Work is at **Annex-III**. The list of employees to be insured alongwith their pre-requisite detail is at **Annex-IV**. The detail of sum insured alongwith schedule of classification is mentioned in the Financial Proposal (**Annex-II**).
- 7). Sealed bids/proposals are required to be delivered at OGRA's office (Plot No. 54-B, Fazal-e-Haq Road, Blue Area, Islamabad) latest by February 24, 2020 on or before 11:00 a.m. The Bid Opening Committee of OGRA will open the Technical/Pre-qualification proposals (**Annex-I**) in the first instance at 11:30 a.m on the same date i.e. February 24, 2020 in the presence of the bidders or their authorized representatives, who may like to be present. Subsequently, the Technical/Pre-qualification proposals shall be evaluated by OGRA's Bid Evaluation Committee as per criteria given at **Annex-V**.

- 8). Bids not complying with the requirements at clauses 1 to 5 above shall be declared as Non-Responsive and their financial proposals shall be returned un-opened.
- 9). The Bid Opening Committee shall open the financial proposals (**Annex-II**) of the bidders whose Pre-Qualification proposals are accepted, on a date and time to be communicated to them in advance, in the presence of the bidders or their authorized representatives, who may like to be present.
- 10). Only one authorized representative per bidder shall be allowed to attend the opening of bids.
- 11). The bid validity period shall be (03) months, starting from the last date for receipt of bids.
- 12). The contract shall be awarded to the lowest evaluated bidder.
- 13). The successful bidder shall be required to enter into a formal Contract Agreement. The contract period will be for two (02) years, effective from the date of award of contract and extendable up to a similar period with mutual consent and subject to following conditions:
 - i. Satisfactory performance of insurance company.
 - ii. Settlement of all claims.
 - iii. Availability of funds.
 - iv. Continuation of policy on the same premium rates, terms and conditions as agreed in the main contract.
- 14). The successful bidder shall be required to deposit a "performance bond" equivalent to 5% of the total value of the bid (12 months) through a call deposit in favour of OGRA payable at Islamabad. After expiry of the validation of Performance Bond, the firm will be required to deposit Performance Bond of same value for another period of one year. If the bidder fails to deposit performance bond within one week of the receipt of the award letter, the same shall be treated as cancelled and the earnest money shall be forfeited.
- 15). 3% earnest money of the un-successful bidders shall be released within 30 days. However, 5% performance bond shall be released to the successful bidder within 30 days after successful completion of two years contract agreement.
- 16). OGRA has right to increase or decrease the number of staff.
- 17). Payment of the bills shall be subject to the deduction of mandatory government taxes/levies.
- 18). This is made obligatory to affix authorized signatures with official stamp on all documents, annexure, copies, certificates, letters, forms and all relevant documents as part of the bids submitted by the bidder.
- 19). It will be the responsibility of the bidder that all factors have been investigated and considered while submitting the bids and no claim whatsoever including those of financial adjustments to the contract awarded under this bid process will be entertained by the purchaser. Neither any time schedule, nor financial

adjustments arising thereof shall be permitted on account of failure by the bidder.

- 20). The bidder shall be deemed to have satisfied itself fully before bid as to the correctness and sufficiency of its bids for the contract and price/cost quoted in the bid to cover all obligations under this bid process.
- 21). Period of payment of death claim should be within 10 to 15 working days.
- 22). Payment of premium will be made on yearly basis.
- 23). All the clauses related to the payment of death claims of deceased OGRA's employees mentioned here in the tender documents, will also be a part of the contract which will be made with the successful bidder.
- 24). The proposals should not have any over-writing or cutting. The Bid Opening Committee of OGRA reserves the right not consider the proposals having aforementioned deficiencies.
- 25). OGRA reserves the right to cancel/reject any or all bids or proposals at any time prior to the acceptance of a bid or proposal as per PPRA Rules, 2004.
