- 1. The Oil and Gas Regulatory Authority (OGRA) invites sealed bids/proposals for provision of Security Services to OGRA's Head Office at Plot No. 54-B, Fazal-e-Haq Road, Blue Area, Islamabad, and its regional offices at Lahore, Karachi & Quetta, initially for a period of two year extendable subject to mutual consent under Tender Enquiry No. 02 of 2020, from well-reputed License holding private security firms/companies who have valid/updated NOCs of Federal/Provinces/District Administration etc., to operate as security company and registered with Income Tax Department etc, stationed at Islamabad/Rawalpindi, having minimum five (05) years relevant experience.

TENDER DOCUMENTS

PROVISION OF SECURITY SERVICES FOR OGRA OFFICES UNDER TENDER ENQUIRY NO. 02 of 2020.

The Oil and Gas Regulatory Authority (OGRA) invites sealed bids for provision of Security Services to its Head Office, 54-B, Fazal-e-Haq Road, Blue Area, Islamabad and its regional offices at Lahore, Karachi & Quetta as per Annex-I&II.

General Terms and Conditions:

- 1). The bidder should submit a single package containing two separate sealed envelopes under Tender Enquiry No. 02 of 2020. One envelope should contain pre-qualification proposal and marked as "TECHNICAL/PRE-QUALIFICATION PROPOSAL" and the other envelope should contain the financial proposal and marked as "FINANCIAL PROPOSAL".
- 2). The firm should be registered with Income Tax Department, EOBI and Social Security Department (Registration Number should be clearly mentioned and attested valid documentary evidence be attached).
- 3). The firm must be a license holder from Ministry of Interior (valid/updated NOCs of Federal/Provinces /District Administration to operate as security company).
- 4). The firm should have a minimum of five (05) years experience of similar assignments and should have a proper setup/office at Islamabad/Rawalpindi.
- 5). The bidder shall be required to submit bid security/earnest money equal to 2% of total bid value along with financial proposal in shape of **Call Deposit** in favour of OGRA payable at Islamabad.
- 6). An original and latest undertaking/affidavit on judicial paper that the firm has not been blacklisted by any Government, Semi Government, Autonomous or any State Owned Organization.
- 7). Sealed bids/proposals are required to be delivered at OGRA office Plot No. 54-B,Fazal-e-Haq Road, Blue Area, Islamabad latest by March 11, 2020 on or before11:00 a.m. The OGRA's Bid Opening Committee shall open the Pre-qualification proposals (Annex-I) at 11:30 a.m on the same day i.e. March 11, 2020 in presence of the bidders or their authorized representatives, who may like to be present. The technical proposals shall be evaluated as per criteria given at Annex-III.
- 8). Bids not complying with the requirements at 2 to 6 above shall be declared as Non-Responsive and their financial proposals shall be returned un-opened.
- 9). The OGRA's Bid Opening Committee shall open the Financial Proposals (Annex-II) of only technically pre-qualified firms, on the date and time to be communicated to them in advance in the presence of bidders or their authorized representative, who may like to be present.

- 10). Only one authorized representative per bidder shall be allowed to attend the opening of bids.
- 11). The contract shall be awarded to the lowest evaluated bidder.
- 12). The bid validity period shall be (03) months, starting from the last date of receipt of bids.
- 13). The successful bidder shall be required to deposit a "Performance Bond" equivalent to 5% of the total value of the quoted amount through a Call Deposit in favour of OGRA payable at Islamabad. If the bidder fails to deposit performance bond within one week of the receipt of the award letter, the same shall be treated as cancelled and the earnest money shall be forfeited.
- 14). 2% earnest money of the un-successful bidders shall be released within 30 days. However, 5% performance bond shall be released within 30 days after successful completion of one year contract period.
- 15). The successful bidder shall be required to enter into a formal Contract Agreement, to be executed with mutual consent of both parties. The contract shall be awarded initially for a period of one year which shall be extendable on same terms & conditions with mutual consent of both parties.
- 16). The proposals should not have any over-writing or cutting. The Bid opening committee of OGRA reserves the right not to consider the proposal having aforementioned deficiencies.
- 17). Payment of the bills shall be subject to the deduction of mandatory government taxes/levies.
- 18). A formal contract agreement mentioning all terms and conditions/TORs etc., will be executed between the successful bidder and OGRA for provision of Security Guards for OGRA Head Office at Islamabad and its regional offices at Lahore, Karachi & Quetta.
- 19). OGRA reserves the right to increase/reduce the number of Security Guards as per its requirements.
- 20). Interested firms may visit the offices of OGRA at any time during working hours.
- 21). The firm while quoting the bids will ensure that Security Guards being provided are duly enlisted with EOBI and Social Security Departments.
- 22). The firm while quoting the bids will ensure payment of minimum wages for security guards as fixed by the Government of Pakistan from time to time.
- 23). It shall be responsibility of the security company to ensure that the security guards, whose services are to be provided to the OGRA, are armed, physically fit, honest, well trained, having knowledge of safety, security procedures/protocol etc.,.

- 24). The security company shall ensure availability of reserve security personnel.
- 25). The security company will be responsible for arranging neat and clean uniforms to the guards including security supervisor.
- 26). Submission of false statements/documents as well as concealing of any information shall lead to, inter alia, disqualification of respective firm.
- 27). Before submission of bid, the terms & conditions of the tender documents must be read carefully otherwise no query except allowed under provision of PPRA Rules, will be entertained after submission of bids and till finalization of tendering process and award of contract.
- 28). OGRA reserves the right to cancel/reject any or all bids/proposals at any time prior to the acceptance as per PPRA Rules, 2004.
