### **TENDER DOCUMENTS**

The Oil and Gas Regulatory Authority (OGRA) invites sealed bids/proposals, from well-reputed and financially sound firms/suppliers having minimum five (05) years relevant experience, registered with income tax, sales tax Departments and SECP, stationed at Islamabad/Rawalpindi for purchase/supply of 48x Laptops (**as per specifications at Annex-II**) to OGRA office located at 54-B, Fazal-ul-Haq Road, Blue Area, Islamabad under Tender Enquiry No.07 of 2020.

#### **General Terms and Conditions:**

- The bidder should submit a single package containing two separate sealed envelopes. One envelope should contain Technical/Prequalification Proposal (**Annex-I**) and the other envelope should contain Financial Proposal (**Annex-II**), both showing the Tender Enquiry No. 07 of 2020 and marked as "**TECHNICAL PROPOSAL**" and "**FINANCIAL PROPOSAL**", respectively.
- 2) The firm should be registered with Income Tax, Sales Tax Departments and SECP (Registration numbers and NTN numbers should be clearly mentioned and valid documentary evidence be attached).
- 3) The bidder will be required to submit a bid security/earnest money equal to 2% of the total quoted value of bid along with Financial Proposal in the shape of **Call Deposit** in favour of OGRA, payable at Islamabad.
- 4) Any bid not accompanied by the required value of call deposit as required under clause 3 shall be rejected.
- The firm should have a minimum of five (05) years experience of supply of Laptops, Computers, Printers, Softwares etc. and should have a well-equipped office-setup/workshop at Islamabad/Rawalpindi.
- The bid validity period will be 90 days, starting from the date of opening of technical bid/proposal and any escalation in dollar against Pak Rupees shall not be applicable as well as any increase in price, within validity period of 90 days, shall be borne by the bidder. No such claim shall be entertained.
- Sealed bids/proposals are required to be delivered at OGRA office Plot No. 54-B, Fazal-ul-Haq Road, Blue Area, Islamabad latest by November 30, 2020 till 11:00 a.m. The OGRA's Bid Opening Committee shall open the Technical/Pre-qualification proposals (**Annex-I**) in the first instance at 11:30 on the same date i.e. November 30, 2020 in the presence of bidders or their authorized representatives who may like to be present. Subsequently, technical/pre-qualification proposals shall be evaluated by OGRA's Bid Evaluation Committee as per evaluation/assessment criteria given at **Annex-III**.
- 8) Bids, which are not accompanied by the documents mentioned at Clause No. 2 & 5 shall be declared Non-Responsive and their financial proposals will be returned unopened.

- 9) The Bid Opening Committee will open the Financial Proposals (**Annex-II**) of the only technically pre-qualified bidders, on a date and time to be communicated to them in advance, in the presence of the bidders or their authorized representatives, who may like to be present.
- 10) The Contract/Purchase order for supply of 48x Laptops will be awarded to the technically prequalified/lowest evaluated bidder.
- 11) If two or more bidders quote equal lowest price in financial proposals, then the contract will be awarded to the one having greater technically evaluated marks, in technical/pre-qualification proposal.
- 12) Only one authorized representative per bidder shall be allowed to attend the opening of bids.
- The successful bidder should be required to deposit a "**Performance Bond**" equivalent to **5%** of the total value of the quoted amount through a **Call Deposit** in favour of OGRA payable at Islamabad. If the bidder fails to deposit performance bond within one week of the receipt of the purchase order, the same shall be treated as cancelled and the earnest money shall be forfeited.
- 14) 2% bid security/earnest money of the un-successful bidders shall be released within 30 days. However, 5% performance bond shall be released to the successful bidder after completion of warranty period.
- Original and latest undertaking/affidavit on judicial paper that the firm has not been blacklisted by any Government/Semi Government/Autonomous or any State-Owned Organization.
- 16) The delivery period for supply of Laptops alongwith Softwares will be four (04) to six (06) weeks after receipt of Purchase Order.
- 17) Before submission of bid, all bidders are advised in their own interest to read carefully the terms & conditions of the tender documents.
- 18) No advance payment shall be made against the supply of equipment / software mentioned in this bidding document.
- 19) Payment shall be made on provision of invoice/bill, after delivery of the equipment / software at OGRA Head office and issuance of satisfactory completion /stock verification /physical inspection certificate by the IT Section of OGRA.
- 20) Payment of the bills will be subject to the deduction of all applicable government taxes.
- 21) The proposals should not have any over-writings or cutting. The bids with any of the aforementioned deficiencies may not be considered.
- OGRA reserves the right to accept or reject any or all proposals or extend the closing date without assigning any reason as per PPRA Rules 2004.
