 - Conformity of the proposed project with the prescribed technical standards to carryout project in line with technical standards as contained in the LNG Policy/prescribed by OGRA.
 - Satisfy criteria as specified in LNG Policy to obtain license for design, construction, operation and to own a LNG terminal.
 - The viability of the sources of supply of LNG and the applicant's demonstrated access thereto;
 - Review of various Agreements such as Gas Sales and Purchase Agreement (GSPA) if integrated project structure; agreement with LNG Terminal Owner and/or Operator and shipping company (if required) in case of unbundled project structure etc.
 - Review technology to be used so that it is suitable, tested and proven internationally for design, construction and operation of LNG facilities.
 - To certify that the Feasibility study undertaken by the applicant is bankable.
 - Review sufficiency of purchase commitment from users or wholesale suppliers of LNG which ensures the recovery of investment to be made by the applicant.
 - A time frame of 30 days will be allowed to the Consultant for review and report.
- 3. OGRA invites reputable consultant firms in the field of LNG with at least 10 years experience of designing and supervision of construction/ operation of LNG facilities including terminals. Interested firms must provide information indicating that they are qualified to perform the Services (brochures including organizational structure, list of clients, annual reports, description of similar assignments, experience in similar conditions and with similar agencies, projects undertaken as lead firm, availability of appropriate skills among permanent/full time staff in the firms, etc.). Consultant Firms may form joint ventures to enhance their qualifications.
