General Terms & Conditions:

- The bidder should submit a single package containing two separate sealed envelopes. One envelope should contain the Prequalification Proposal (Annex-I) and the other envelope should contain the Financial Proposal (Annex-II), both showing the Tender Enquiry No. 03 of 2010-11 and marked as "PRE-QUALIFICATION PROPOSAL" and "FINANCIAL PROPOSAL", respectively.
- 2) The firm should be registered with Income Tax and Sales Tax Departments (Registration Numbers should be clearly mentioned and valid documentary evidence be attached).
- 3) The firm should be registered with Pakistan Standard Quality Control Authority (PSQCA) (Registration numbers should be clearly mentioned and valid documentary evidence be attached).
- 4) The firm should be submitted the latest three (03) Laboratory Reports and ISO Certification (valid documentary evidence be attached).
- 5) The firm will be required to mention number of dispensers to be provided to OGRA on complementary basis. The routine/periodical repair & maintenance of dispenser will be carried out by the firm itself.
- 6) The firm should have a minimum of five (05) years experience of supply of bottled/mineral water and the firm should have a well-equipped setup/plant(s) and proper office at Islamabad/Rawalpindi.
- 7) The bidder will be required to submit Security Deposit in the shape of Bank's Pay Order for Rs. 25,000/- (Rupees twenty five thousand only) payable at Islamabad, in favour of OGRA. The security of non-prequalified firms will be released within seven (07) days after completion of the pre-qualification process. Cash/Cheque will not be accepted.
- 8) Sealed tenders are required to be delivered to the office of the undersigned latest by 11:00 a.m on December 30, 2010.

- 9) The bid validity period will be three (03) months, starting from the last date of bid submission.
- The Bid Opening Committee of OGRA will open the Pre-qualification proposals (Annex-I) in the first instance for evaluation per criteria given at Annex-III, on December 30, 2010 at 11:30 a.m in the presence of the bidders or their authorized representatives, who may like to be present. Bids, which are not accompanied by the documents at serial No. 2 to 5, above, shall be declared Non-Responsive and their financial proposals will be returned unopened.
- 11) The Bid Opening Committee will open the financial proposals (**Annex-II**) of the bidders whose pre-qualification proposals are accepted, on a date and time to be communicated to them in advance, in the presence of the bidders or their authorized representatives, who may like to be present.
- 12) Only one authorized representative per bidder will be allowed to attend the opening of bids. A representative from a bidder will be required to submit an authority letter in his/her favour by the respective bidders for attending the opening of bids.
- 13) The successful bidder will be required to enter into a formal contract agreement to be executed with mutual consent of both the parties.
- 14) The successful contractor/firm shall be bound to undertake to supply bottled/mineral water as per quality and standards laid down by PSQCA from time to time to OGRA offices situated at 54-B, Fazal-e-Haq Road, Blue Area, Islamabad & Block-9 (Al-Fabric building), Civic Centre, G-6, Islamabad.
- 15) The delivery period is required to be within one day of receipt of Purchase Order.
- 16) The proposals should not have any over-writings or cutting. Bids with any of the aforementioned defects may not be considered.
- 17) The contract will be awarded to the lowest evaluated bidder.
- 18) Payment of the bills will be subject to the deduction of government taxes.
- 19) OGRA reserves the right to accept or reject any or all proposals or extend the closing date without assigning any reason.
