The Oil and Gas Regulatory Authority (OGRA) hereby invites sealed bids as per **Annex-I**, from interested parties for sale of its Motor Vehicle i.e Chevrolet Optra, 1600 CC (Model 2005), which is in good running condition, under Tender Enquiry No. 18 of 2010-11.

General Terms and Conditions:

1. The motor vehicle will be sold on “as is where is” basis.
2. The bidder will be required to submit a Pay Order for an amount equal to 2% of the total value of bid as earnest money in the form of Pay Order in favour of OGRA, payable at Islamabad.
3. Any bid without earnest money or with any condition shall be rejected.
4. The successful bidder will be required to pay an amount equal to 20% the bid money in cash or through pay order, before the close of the working hours on the next working day. In case of failure to deposit the said amount with OGRA, earnest money will be forfeited in favour of OGRA.
5. On acceptance of the bid, the bidder will be required to pay the balance amount within seven (07) days in the form of pay order in favour of OGRA, payable at any bank in Islamabad and remove the vehicle immediately at his/her own risk & cost. In case of failure of the successful bidder in depositing the balance amount within prescribe time limit of seven days, his/her earnest money as well as 20% advance shall be forfeited in favour of OGRA.
6. The bids are required to be delivered to the office of the undersigned by 11:00 a.m on June 13, 2011. The Disposal Committee will open the bids on the same day at 11:30 a.m in the presence of the bidders, or their authorized representatives, who may like to be present.
7. Interested parties must bring their original or attested photocopy of CNIC with them.
8. The vehicle will be sold to the highest evaluated bidder.
9. The successful bidder will be required to pay 5% of bid as Income Tax.
10. The 2% earnest money will be refunded to the unsuccessful bidders within five (05) working days of the bidding date.
11. The OGRA employees and their families will not be entitled to participate in the bidding process.
12. OGRA reserves the right in its sole discretion to accept or reject any or all bids without justifying any reasons thereof before accepting any bids.
