NOTICE OF PUBLIC HEARING BY THE AUTHORITY TO CONSIDER ELENY TERMINAL PAKISTAN LIMITED (ETPL)'S APPLICATION TO UNDERTAKE REGULATED ACTIVITIES RELATED TO LIQUEFIED NATURAL GAS (LNG) AT PORT QASIM, KARACHI.

Elengy Terminal Pakistan Limited (the applicant) filed a petition on July 26, 2013 with OGRA under Rule 4 of Oil and Gas Regulatory Authority (LNG) Rules, 2007 to undertake the following regulated activities at Port Qasim, Karachi:-

- i. Construction and operation of LNG Receiving Terminal,
- ii. Construction and operation of LNG Storage Facility,
- iii. LNG Processing, Testing Facility (Construction and Operation), Transportation of LNG, Filling of LNG, Marketing and Distribution of LNG

2. In pursuance of LNG Policy 2011 and LNG Rules, 2007, SGS (Consultant/Expert) was appointed by OGRA to determine whether the application of ETPL meets the requirements of LNG Policy 2011, OGRA Ordinance and LNG Rules, 2007. SGS submitted its report to OGRA on 31st January 2014 and concluded that application filed by ETPL fulfills the requirements of LNG Rules, 2007 and LNG Policy 2011 to undertake the following regulated activities at Port Qasim, Karachi:-

- a. LNG Storage Facility (Construction)
- b. LNG Storage Facility (Operation)
- c. LNG Terminal (Construction)
- d. LNG Terminal (Operation)

3. OGRA, keeping in view the SGS's report, has admitted the petition of ETPL under LNG Rules, 2007 for further processing / consideration.

4. OGRA invites all interveners and interested / affected persons and parties to furnish their comments / interventions / views, if any, on the petition filed by the applicant, within 14 days from date of publication of this notice. The intervention request be addressed to the Registrar, OGRA, containing the name and address of the intervener and be accompanied by an affidavit verifying the contents of the intervention and intervention fee of Rs. 500/- (demand draft in favor of Oil & Gas Regulatory Authority, payable at Islamabad). In case of a person representing any organization/agency/body, (s)he must file an authority letter of the same.

5. Copy of ETPL's petition and SGS's evaluation report etc. can be obtained on payment of prescribed charges of Rs. 2/- per page from the office of the Registrar OGRA, Islamabad.
