



# **OIL & GAS REGULATORY AUTHORITY (OGRA)**

## **NOTICE OF PUBLIC HEARING**

### **APPLICATION BY ELENGY TERMINAL PAKISTAN LIMITED FOR GRANT OF LICENCE FOR TRANSMISSION OF NATURAL GAS**

1. Elengy Terminal Pakistan Limited (ETPL) (the applicant) has applied under Section 23 of Oil and Gas Regulatory Authority Ordinance, 2002 read with Rule 4 of the Natural Gas (Licencing) Rules, 2002 for the grant of licence to carry out the regulated activity of Transmission of Natural Gas from applicant's jetty to tie in point at SMS Pakland. The Authority has admitted the application of Elengy Terminal Pakistan Limited for consideration.
2. The applicant has informed that with reference to Govt. of Pakistan's tender for provision of services of transportation, storage, re-gasification of LNG and re-delivery of gas into SSGCL's existing natural gas network they intend to participate and one of the Tender's requirement is to deliver RLNG or natural gas to one of the two designated tie in points to SSGCL's existing high pressure network. The applicant provided approx coordinates of tie in point at SMS Pakland and stated that the tie in point is at a distance of 22 KMs from their jetty. Subject to award of this fast track LNG Project, the applicant will lay a transmission line of 24" diameter from their jetty to the aforesaid tie in point.
3. OGRA invites all interveners and interested / affected persons and parties to furnish their comments / interventions / views, if any, on the petition filed by the applicant, within 14 days from date of publication of this notice. The intervention request be addressed to the Registrar, OGRA, containing the name and address of the intervener and be accompanied by an affidavit verifying the contents of the intervention and intervention fee of Rs. 500/- (demand draft in favor of Oil & Gas Regulatory Authority, payable at Islamabad). In case of a person representing any organization/agency/body, (s)he must file an authority letter of the same.
4. OGRA has decided to hold a Public Hearing at Islamabad on the subject matter according to the date, time and venue mentioned below:
