NOTICE OF PUBLIC HEARING

**APPLICATION BY OIL AND GAS DEVELOPMENT COMPANY LIMITED
FOR GRANT OF LICENCE FOR SALE OF NATURAL GAS**

Oil and Gas Development Company Limited (OGDCL) (applicant) has applied under Rule 4 of the Natural Gas (Licencing) Rules, 2002 for the grant of licence to carry out the regulated activity of the sale of Natural Gas from Reti-Marū (Marū South) Gas field to Engro Fertilizers Limited.

The applicant has stated that Reti-Marū and Marū South gas fields, falling within the Gaddu Concession area and located within the District of Ghotki province of Sindh, Pakistan, have hydrocarbon reserves which are being supplied to Engro Fertilizers Limited. In pursuance of Economic Coordination Committee (ECC)'s decision dated 22-02-2013, (11-13 MMCFD SNGPL equivalent) gas has been allocated to Engro Fertilizers for the interim period till the implementation of ECC decision on case No.ECC 167/16/2012 dated 18-12-2012 whereby gas has been allocated from Reti Marū to Four Fertilizer Consortium (FFM). The applicant has also informed that OGDCL has finalized an interim Gas Sales Agreement with Engro Fertilizers in accordance with ECC decision dated 22-02-2013. The Authority has admitted the application of OGDCL for consideration.

All persons and parties who are likely to be affected by the grant of licence are hereby notified to file objections, written statements or intervention request addressed to Registrar OGRA, describing the manner in which such persons shall be affected. The application shall be filed alongwith fee of Rs.500/- (bank draft) and affidavit verifying the contents of communication, within 14 days of publication of this notice with a copy to the applicant. Copies of the documents can be obtained on payment of prescribed charges of Rs.2/- per page from the office of the Registrar.
