



# OIL & GAS REGULATORY AUTHORITY (OGRA)

## NOTICE OF PUBLIC HEARING

### Pakistan Gasport Consortium Limited (PGPC)'s application for modification of its license to undertake regulated activities related to Liquefied Natural Gas (LNG) at Port Qasim, Karachi

Pakistan Gasport Consortium Limited (PGPC) (the applicant) the wholly owned subsidiary company of Pakistan Gasport Limited (PGPL) filed an application with OGRA for modification of its license's terms and conditions w.r.t. Terminal Construction Period, Change in License Type from integrated to un-bundled project structure. The applicant was granted a subject license on 03-10-2011 to undertake the following regulated activities at Port Qasim, Karachi:-

- (i) **Construction of LNG Receiving Terminal**
- (ii) **Construction of LNG Receiving and Re-Gasification Facility including LNG Unloading, Marine Facility, LNG Storage Facility, Vaporization and RLNG Send Out Facility**

The applicant has intimated that it is establishing Pakistan's second LNG Import Terminal pursuant to the 15-years LNG Operations and Services Agreement signed with state owned Pakistan LNG Terminal Limited (PLTL) on 01-07-2016, after approvals, inter alia, from the Federal Cabinet's ECC and Ministry of Law and Justice. The applicant along with other Consortium Partner i.e. FOTCO intends to commission the terminal by 30-06-2017. For the instant project, the applicant has planned to utilize the site of FOTCO i.e. Mazhar Point at Port Qasim. The applicant has requested the Authority to modify its license pursuant to aforesaid submissions. The Authority has admitted the application for modification of terms & conditions of license under Rule 22 of the Oil & Gas Regulatory Authority (LNG) Rules, 2007.

OGRA invites all interveners and interested / affected persons and parties to furnish their comments / interventions / views (if any), on the petition filed by the applicant, within **14 days** from the date of publication of this notice. The intervention request be addressed to the Registrar, OGRA, must contain the name and address of the intervener and be accompanied by an affidavit verifying the contents of the intervention and intervention fee of **Rs. 500/-** (demand draft in favour of Oil & Gas Regulatory Authority, payable at Islamabad). In case of a person representing any organization / agency / body, he must file an authority letter of the same.
