The Oil and Gas Regulatory Authority (OGRA) invites sealed bids/proposals from well-reputed firms/suppliers/distributors having five (05) years relevant experience, registered with income tax, sales tax departments and PSQCA and having certification of PCRWR and ISO 9001, ISO 14001, ISO 2200 and OHSAS 18001 for supply of quality bottled/drinking water through dispensers for its employees (250 approx.) working in OGRA office building i.e. Plot No. 37 & 39, Mauve Area, Service Road South, Sector G-10/4, Islamabad initially for a period of two years extendable on the same terms & conditions upon expiry, with the mutual consent of both parties, under Tender Enquiry No.03 of 2024.

#### **General Terms & Conditions:**

- The bidder should submit a single package containing two separate sealed envelopes. One envelope should contain the Technical Prequalification Proposal (Annex-I) and the other envelope should contain the Financial Proposal (Annex-II), both showing the Tender Enquiry No. of 2024 and marked as "TECHNICAL/PRE-QUALIFICATION PROPOSAL" and "FINANCIAL PROPOSAL", respectively.
- 2) The firm should be registered with Income Tax and Sales Tax Departments (Registration Numbers should be clearly mentioned and valid documentary evidence be attached) being on active tax payers list.
- The firm should be registered with Pakistan Standard Quality Control Authority (PSQCA) (Registration numbers should be clearly mentioned and valid documentary evidence be attached).
- 4) The firm should submit the latest three (03) Laboratory Reports and ISO Certification (valid documentary evidence be attached).
- 5) The firm will be required to mention number of dispensers to be provided to OGRA on complementary basis. The routine/periodical repair & maintenance of dispensers will be carried out by the firm itself.
- 6) The firm should have a minimum of five (05) years' experience of supply of bottled/drinking water and should have a well-equipped setup/plant(s) and proper office at Islamabad/Rawalpindi.
- 7) The bidder will be required to submit Security Deposit of Rs. 50,000/-in the shape of Call Deposit payable at Islamabad, in favor of OGRA. The security of non-prequalified firms will be released within seven (07) days after completion of the pre-qualification process. However, the security deposit of the firm will be retained till the expiry of the contract without any claim for payment of interest. Cash/Cheque will not be accepted.
- 8) The bid validity period will be three (03) months, starting from the last date of bid submission.
- 9) Sealed bids/proposal are required to be delivered to the office of the undersigned latest by 11:00 a.m. on or before February 20, 2024, The Bid Opening Committee of OGRA will open the Technical/Pre-qualification proposals (Annex-I) in the first

- instance on the same date i.e. February 20, 2024, at 11:30 a.m. in the presence of the bidders or their authorized representatives, who may like to be present. Subsequently, Technical/Pre-qualification Proposals will be evaluated by OGRA's Bid Evaluation Committee as per criteria given at (Annex-III).
- 10) Bids, which are not accompanied by the documents mentioned above, shall be declared Non-Responsive and their financial proposals will be returned unopened.
- 11) The Bid Opening Committee will open the financial proposals (Annex-II) of the bidders whose technical pre-qualification proposals are accepted, on a date and time to be communicated to them in advance, in the presence of the bidders or their authorized representatives, who may like to be present.
- 12) Increase or decrease of drinking water bottle can be made with mutual consent of both the parties i.e. OGRA and successful bidder / firm on same terms & conditions.
- 13) Only one authorized representative per bidder will be allowed to attend the opening of bids. A representative from a bidder will be required to submit an authority letter in his/her favor by the respective bidders for attending the opening of bids.
- 14) The successful bidder will be required to enter into a formal contract agreement to be executed with mutual consent of both the parties.
- 15) The successful contractor/firm shall be bound to undertake to supply bottled/drinking water as per quality and standards laid down by PSQCA from time to time to OGRA office situated at plot No. 37 & 39, Mauve Area, Service Road South, Sector G-10/4, Islamabad.
- The Contract shall be awarded initially for a period of two (02) years starting from the date of signing of contract which shall be extendable on the same terms & conditions upon expiry, with the mutual consent of both parties with 10% increase on the quoted / prevailing rates after completion of contract period with a view to mitigate the prevailing effects of inflation & devaluation.
- 17) The successful bidder is bound to deliver bottled / drinking water within one day of receipt of Purchase Order.
- 18) The proposals should not have any over-writings or cutting. Bids with any of the aforementioned deficiencies will not be considered.
- 19) Original and latest undertaking/affidavit on judicial paper that the firm has not been blacklisted by any Government/Semi Government, Autonomous or any State-Owned Organization.
- 20) The contract will be awarded to the most advantageous evaluated bidder. quality and hygienic standards of the product shall not be compromised.
- Payment of the bills will be subject to the deduction of government taxes.
