General Terms & Conditions:

- 1) The bidder should submit a single package containing two separate sealed envelopes. One envelope should contain the Pre-qualification/Technical Proposal (**Annex-I**) and the other envelope should contain the Financial Proposal (**Annex-II**), both showing the tender enquiry No. 05 of 2024 and marked as "**TECHNICAL PROPOSAL**" and "**FINANCIAL PROPOSAL**" respectively.
- 2) The firm should be registered with Income Tax, Sales Tax Departments (Registration Numbers should be clearly mentioned and valid documentary evidence be attached).
- 3) The firm should have relevant experience of minimum five (05) years of similar nature projects in subject/video conferencing setup installation etc., preferably stationed at Islamabad/Rawalpindi. Documentary proof e.g copies of purchase orders and list of clientage must be attached in support of relevant experience.
- 4) The bidder will be required to submit a bid security/earnest money equivalent to **3%** of the total quoted value of bid alongwith Financial Proposal in shape of **Call Deposit** from any scheduled Bank of Pakistan in favour of OGRA, payable at Islamabad.
- 5) The bid validity period will be three (03) months, starting from the date of opening of technical bids. The rates quoted by the bidder are final & fixed and no inflation/escalation in dollar against Pak rupees will be paid by OGRA and any increase in price shall also not be borne by OGRA. No such claim from the bidder will be entertained.
- 6) Sealed bids/ proposals are required to be delivered at OGRA office situated at Plot No. 37 & 39, OGRA Headquarter, Mouve Area, Sector G-10/4, Islamabad latest by March 19, 2024 on or before 11:00 a.m. The Bid Opening Committee of OGRA shall open the Technical/Pre-qualification proposals (**Annex-I**) in the first instance at 11:30 on the same date i.e. March 19, 2024 in the presence of bidders or their authorized representatives, who may like to be present. Subsequently, technical/pre-qualification proposals shall be evaluated by OGRA's Bid Evaluation Committee as per the terms & conditions of bidding documents & Criteria given at **Annex-III**.
- 7) The detailed scope of work is at **Annex-IV** which may please be read carefully before submission of bid in a proper way.

- 8) Bids, which are not accompanied by the documents mentioned at Clause No. 2, 3 & 4 shall be declared **Non-responsive** and their financial proposals will be returned unopened.
- 9) The Bid Opening Committee will open the financial proposals (**Annex-II**) of the only these bidders who are technically pre-qualified, on a date and time to be communicated to them in advance, in the presence of the bidders or their authorized representatives, who may like to be present.
- 10) Only one authorized representative per bidder shall be allowed to attend the opening of bids.
- 11) The Successful Bidder should be required to deposit a “**Performance Bond**” equivalent to 10% of the total value of the quoted amount through a **Call Deposit** in favour of OGRA payable at Islamabad. If the bidder fails to deposit the Performance Bond within one week of the receipt of the Purchase/Work Order, the same shall be treated as cancelled and 3% Earnest Money already deposited by the bidder shall be forfeited.
- 12) 3% earnest money of the un-successful bidders shall be released within 30 days. However, 10% Performance Bond shall be released after completion of task and support & service period i.e. satisfactory supply/delivery/installation of subject work at OGRA’s building situated at Plot No. 37 & 39, Sector G-10/4, Islamabad and warranty period, if any.
- 13) The proposals should not have any over-writings or cutting. The bids with any of the aforementioned deficiencies may not be considered.
- 14) The firm should have to attach Original and latest **undertaking/ Affidavit** on judicial paper that the firm has not been blacklisted by any Government, Semi-Govt., Autonomous body or any state-owned organization.
- 15) An **undertaking** on affidavit shall be submitted by the bidder/firm, indicating that to accept all terms & conditions given in tender. Acceptance that bidding firm has participated in full tender for providing each and every item/solution on turns key basis i.e. the project must be treated as a Turnkey solution and an intended vendor must offer all items, in case of any discrepancy or less item the Bid will be rejected/ work order will be cancelled and earnest money will be forfeited without any responsibility on OGRA for any expenditure already incurred on the project by the vendor.

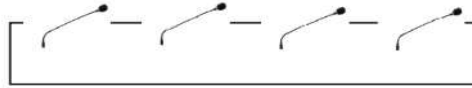
