The Oil and Gas Regulatory Authority (OGRA) invites sealed bids/proposals, for Pre-qualification of Firms as per Annex-I for supply as and when required basis of Computers, Laptops, Printers, MS Softwares, Scanners & its Allied Accessories etc. under Tender Enquiry No. 10/2024, for a period of two (02) years, which is extendable on the mutual consent on same terms & conditions.

General Terms and Conditions:

- 1) The firm should be registered with Income Tax, Sales Tax Departments and SECP (Registration Numbers should be clearly mentioned and valid documentary evidence should be attached).
- 2) The firm should have a minimum of five (05) years relevant experience of similar assignments and should have proper setup and office at Islamabad/ Rawalpindi.
- The pre-qualified firms would be required to submit Security Deposit in the shape of **Call Deposit** of **Rs.100,000/-** (Rupees one hundred thousand only) payable at Islamabad/Rawalpindi, in favour of OGRA and in case of failure, the pre-qualification of the firm will be treated as cancelled. The security will be released to the firms within 30 days after expiry of the period of Pre-qualification. Cash/Cheque will not be accepted.
- 4) As and when a purchase order is placed to the firm, it will be required to deposit a "Performance Bond" equivalent to 10% of the total value of the supply/purchase order in shape of **Call Deposit** payable at Islamabad. In case the firm/supplier fails to deposit performance bond within one week of the receipt of supply/purchase order, the same shall be treated as cancelled and the security deposit may be forfeited.
- 5) Payments of the bills will be subject to the deduction of government taxes/levies.
- 6) Sealed bids/proposals are required to be delivered at OGRA office located at Head Office Building, Plot No. 37 & 39, Sector G-10/4, Mauve Area, Islamabad latest by May 08, 2024 on or before 11:00 a.m. The Bid Opening Committee shall open the Technical/Prequalification proposals (Annex-I) at 11:30 a.m. on the same date i.e. May 08, 2024 in the presence of bidders or their authorized representatives who opt to participate. Subsequently, Technical/Pre-qualification Proposals will be evaluated by OGRA Bid Evaluation Committee as per criteria given at Annex-II.
- 7) Only one authorized representative per bidder shall be allowed to attend the opening of bids.
- 8) An original and latest undertaking/affidavit be attached on judicial paper that the firm has not been blacklisted by any Govt, Semi Govt, Autonomous Bodies or any State owned organization.
- 9) OGRA reserves the right to extend the opening date of the bids, cancel/reject any or all proposals as per PPRA Rules
