CNG SECTOR

CNG sector is regulated under OGRA ordinance 2002, CNG (Production and Marketing) Rules 2002 and Policies of the Federal Government in vogue.

- Renewal of Existing CNG Marketing Licence

CHECKLIST

New CNG Licence

The Federal Government has imposed ban on the issue on new CNG Licences i.e. for establishment of CNG Station since February 2008. The existing CNG Marketing Licences earlier granted for a fifteen years are however renewable under Rule 7 of Rules ibid for a year of five years.

Renewal of Existing CNG Marketing Licence

CHECKLIST

- > Formal request on letter head of the concerned CNG Station duly signed by the authorized signatory.
- ➤ License Renewal Fee of Rs.25,000/- (Rupees twenty-five thousand only) in favour of OGRA in the form of Pay Order / Bank Draft.
- > Attested copy of valid/ renewed Explosive License on "Form-B" issued by the Department of Explosives, Ministry of Industries, Govt. of Pakistan.
- NOC from concerned Oil Marketing Company, if applicable.
- > An Undertaking on legal paper w.r.t litigation free site.
- Re-confirmation letter w.r.t. issuance of Explosive Licence from Chief Inspector of Explosives to the applicant/ licensee.


Note:-

- (i) Conformance to the CNG Rules 1992/ Standard code of practice being ensured through Third Party Inspectors report;
- (ii) Clearance of any pending annual inspection fee or penalty, as applicable.

| 11. | Whether CNG station needs to be in compliance with the provision of CNG Rules, 1992 to acquire renewal in its CNG Marketing License. | Yes and the same is ascertain through third party inspection report of the concerned CNG Station. |

| 12. | Whether NOC from concerned Oil Marketing Company is required for renewal in CNG Marketing License. | Yes but only for the case, if Petrol Pump is established on the premises of the concerned CNG Station. |
| 13. | Whether licenses needs to submit affidavit to the effect that there is no change in the physical location of CNG Station to acquire renewal in its CNG Marketing License. | Yes and as per OGRA's prescribed format which interalia includes confirmation to the effect that there is no change in the physical location of CNG Station. |
| 14. | Whether there should be no court case pending in any Court of Law which restricts OGRA from renewal in CNG Marketing License. | Yes and the same is established through the prescribed affidavit submitted by the licensee. |
| 15. | Whether confirmation letter is required from Explosive Department for renewal in CNG Marketing Licence. | Explosive Department to the effect that Form-B is granted after completion of applicable formalities/ safety rules is required before renewal of CNG Marketing Licence. |
| 16. | Why renewal of every CNG Marketing Licence is mandatory. | License is violation of Rule-3 of CNG Rules, 1992. Therefore, it is mandatory to have valid CNG Marketing License for operation of any CNG Station. |
| 17. | Whether request regarding renewal in CNG Marketing Licence needs to be submitted on proper letter head of concerned CNG Station. | Marketing Licence needs to be submitted on letter head of the concerned CNG Station. |



| 18. | Whether formal request for renewal in CNG Marketing Licence needs to be signed through authorized signatory. | Yes formal request regarding renewal in CNG Marketing Licence needs to be signed by authorized signatory of the concerned CNG Station. |
