

# PUBLIC NOTICE

## REQUEST OF GAS COMPANIES FOR APPROVAL OF CONTRACTS FOR SUPPLY OF RLNG TO DOMESTIC, COMMERCIAL AND INDUSTRIAL CONSUMERS

1. Government of Pakistan has allocated Re-gasified Natural Gas (RLNG) volumes to Sui Northern Gas Pipelines Limited (SNGPL) and Sui Southern Gas Company Limited (SSGCL) for various categories of consumers. Subsequently, SNGPL (the petitioner) filed petitions before the Authority for approval of contracts for supply of RLNG for domestic, commercial and industrial consumers along with a Supplemental RLNG Commercial Contract, to fulfill the requirement of Rule 20 (viii) of NGRA Licensing Rules 2002 and License Conditions 39.1, 39.4, 39.5 and 39.6 granted to them. Since terms and conditions of the contracts are uniform and RLNG allocation is being made to both the Gas Companies, therefore the subject contracts will be considered by the Authority for approval or otherwise for both the Gas Companies.
2. In accordance with the GoP's policy, the proposed RLNG Domestic Contract shall only be applicable to the RLNG based domestic connections in new housing colonies/ societies. The proposed RLNG Commercial and Industrial Contracts shall be applicable only to the new commercial and industrial consumers. Whereas, the Supplemental RLNG Commercial Contract shall cover the RLNG supplies to the existing indigenous gas commercial consumers, opting for load enhancement on RLNG tariff.
3. In view of the above petitions, OGRA hereby invites all consumers, interveners, general public and interested / affected persons and parties to furnish their comments / interventions / views, if any, on the subject petitions filed by the petitioner within 15 days from the date of publication of this notice. All correspondence in this matter may be addressed to Registrar, OGRA and should contain the names and addresses of the petitioner.
4. All interveners must indicate the manner in which they are likely to be affected. Intervention request should be accompanied by an affidavit verifying the contents of the intervention, intervention fee of Rs.500/- (demand draft in favour of OGRA) and authority letter, if representing an organization/entity.
