In exercise of the powers conferred by sub-section (3) of Section 8 of Oil and Gas Regulatory Authority Ordinance, 2002 (XVII of 2002), the Authority, in supersession of its notification No. S.R.O. 1234 (I)/2018 dated October 04, 2018, S.R.O. No. 1284 (I)/2018 dated October 18, 2018, S.R.O. No. 1523 (I)/2018 dated December 14, 2018 and S.R.O. 
