The Oil and Gas Regulatory Authority (OGRA) invites sealed bid on lump sum basis on prescribed proforma as pr **Annex-I**, from interested individuals/parties for auction of its store items etc., as per list at **Annex-II**.

General Terms and Conditions:

- 1. The old/used scrapped items of stores will be auctioned through seal bid on the basis of "As is and where is".
- 2. The bidder will be required to submit the bid for all store items as at **Annex-II**, on lump sum basis. Partial bid will not be accepted.
- 3. The bidder will be required to submit a Pay Order equal to 2% of the total value of the bid as earnest money in favour of OGRA payable at Islamabad.
- 4. Any bid without earnest money or with any condition shall be rejected immediately after opening the bids by the Disposal Committee of OGRA.
- 5. The successful bidder will be required to pay an amount equal to 20% of total bid money (in cash or through pay order), before close of the working hours of the next working day and balance amount will be payable within five (05) working days in the form of pay order in favour of OGRA, payable at any bank in Islamabad, otherwise the bid will be cancelled and its earnest money as well as 20% advance shall be forfeited in favour of OGRA.
- 6. 2% earnest money, if not adjusted in the 20% of the total bid amount, will be released to the bidder after depositing of 80% bid amount.
- 7. The successful bidder will remove the relevant store items immediately at his own risk and cost, after depositing the full payment within five (05) days.
- 8. The successful bidder will be required to pay income tax imposed by the Government i.e. 10% in case of filer and 20% in case of non-filer.
- 9. The bids are required to be delivered to the office of the undersigned by 11:00 a.m on December 03, 2019. The Disposal Committee of OGRA will open the bids for further process on same day at 11:30 a.m in the presence of the bidders, or their authorized representatives, who may like to be present.
- 10. Interested individuals/parties must bring their original CNIC or attested copy of same with them.
- 11. The OGRA employees and their families will not be entitled to participate in any of the bidding process for any item for sale.
- 12. OGRA reserves the right to accept or reject any or all proposals or extend the closing date of the bids without assigning any reason in accordance to PPRA Rules 2004.
