## NOTICE FOR PUBLIC COMMENTS / HEARING

### APPLICATION FOR GRANT OF LICENCE BY MARI PETROLEUM COMPANY LIMITED FOR SALE OF DISSOLVED LOW PRESSURE GAS TO S.N. MINERALS FROM KALABAGH-1A FIELD (KARAK BLOCK)

Mari Petroleum Company (Private) Limited, (MPCL) (the applicant) had applied under OGRA's Natural Gas (Licencing) Rules, 2002 for grant of license for Sale of dissolved Low-Pressure Gas / Natural Gas. MPCL is a subsidiary of Fauji Foundation (40%) thereby holding major controlling power. The applicant requested license for utilization of upto 0.10 MMscfd of dissolved Low Pressure, low volume Gas in its concession area for sale to S.N. Minerals from its Kalabagh-1 Field (Karak Block) located in District Mianwali Punjab.

After completion of the requisite data / information by the applicant, the Authority has admitted the instant application for Public Comments and Hearing.
