NOTICE FOR PUBLIC COMMENTS / HEARING

M/S PUNJAB INDUSTRIAL ESTATES DEVELOPMENT AND MANAGEMENT COMPANY (PIEDMC)- APPLICATION FOR GRANT OF LICENCE FOR DISTRIBUTION AND SALE OF NATURAL GAS/RLNG AT QUID-E-AZAM BUSINESS PARK (QABP), SHEIKHUPURA.

M/s Punjab Industrial Estates Development and Management Company, (PIEDMC) Lahore (the applicant) had applied under OGRA Natural Gas (Licensing) Rules, 2002 on 11-02-2022 for grant of license for Distribution and sale of Natural Gas/RLNG for Quid-e- Azam Business Park (QABP) Sheikhupura.
