General Terms & Conditions

- The bidder should submit a single package containing two separate sealed envelopes.
 One envelope should contain "Technical/Prequalification Proposal" (Annex-I) and the
 other envelope should contain "Financial Proposal" (Annex-II), both showing the
 Tender Enquiry No. 10 of 2022, and marked as "TECHNICAL PROPOSAL" and
 "FINANCIAL PROPOSAL", respectively.
- The firm should be registered with Income Tax and Sales Tax Departments; Registration Numbers and NTN numbers should be clearly mentioned and valid documentary evidence be attached.
- 3. The bidder will be required to submit a Bid Security/earnest money equal to 3% of the total quoted value of bid along with Financial Proposal in the form of **Call Deposit** in favor of OGRA, payable at Islamabad.
- 4. Any bid not accompanied by the required value of **Call Deposit** shall be rejected.
- 5. The firm should have a minimum of five (05) years relevant experience and should have a well-equipped & maintained office set-up.
- 6. The bid validity period will be three (03) months, starting from the date of opening of technical bids. The rates quoted by the bidder are final & fixed and no inflation/ escalation in dollar against Pak rupees will be paid by OGRA and any increase in price shall also not be borne by OGRA. No such claim from the bidder will be entertained.
- 7. Sealed bids/ proposals are required to be delivered at OGRA's Head Office, Plot No. 54-B, Fazalul Haq Road, Blue Area, Islamabad latest by **December 15, 2022** on or before **11:00 a.m.** The Bid Opening Committee of OGRA shall open the Technical/ Prequalification proposals (**Annex-I**) in the first instance at 11:30 on the same date i.e. **December 15, 2022** in the presence of bidders or their authorized representatives, who may like to be present. Subsequently, technical/pre-qualification proposals shall be evaluated by OGRA's Bid Evaluation Committee as per the terms & conditions of bidding documents and evaluation criteria given at **Annex-III**.
- 8. Bids, which are not accompanied by the documents mentioned at Clause No. 2 & 3 shall be declared Non-responsive and their financial proposals will be returned unopened.
- 9. The Bid Opening Committee will open the financial proposals (Annex-II) of the only bidders whose technical/ pre-qualification proposals are accepted, on a date and time to be communicated to them in advance, in the presence of the bidders or their authorized representatives, who may like to be present.

- 10. Only one authorized representative per bidder shall be allowed to attend the opening of bids.
- 11. Interested parties/bidders are advised in their own interest to visit OGRA's Regional Office Peshawar to see the feasibility of required renovation works in consultation with OGRA's Regional Head Peshawar (091-9225327), prior to submission of their bids/proposals.
- 12. The Successful Bidder should be required to deposit a "Performance Bond" equivalent to 5% of the total value of the quoted amount through a Call Deposit in favour of OGRA payable at Islamabad. If the bidder fails to deposit the Performance Bond within one week of the receipt of the Purchase/ Work Order, the same shall be treated as cancelled and 3% Earnest Money already deposited by the bidder shall be forfeited.
- 13. 3% earnest money of the un-successful bidders shall be released within 30 days. However, 5% Performance Bond shall be released after completion of task i.e. satisfactory renovation works and warranty period, if any.
- 14. The proposals should not have any over-writings or cutting. The bids with any of the aforementioned deficiencies may not be considered.
- 15. The firm should have to attach Original and latest undertaking/ Affidavit on judicial paper that the firm has not been blacklisted by any Government, Semi-Govt., Autonomous body or any state-owned organization.
- 16. An undertaking on letter head pad, indicating that all information provided herein and documents attached with the proposal are correct and if any information/ documents found incorrect, false or fake etc., the Authority reserves the right to disqualify and blacklist the firm.
- 17. The successful bidder/ firm shall be bound to complete the renovation works of OGRA's Regional Office Peshawar situated at Sarhad Chamber of Commerce & Industry, GT Road, Peshawar, as per layout plan (Annex-IV), specifications/ BoQs, standard, quality & design as mentioned in the tender documents within a period of twenty (20) days from the date of receipt of work/purchase order.
- 18. Before submission of bid, all bidders are advised in their own interest to read carefully the terms & conditions of the tender documents and attach legible copies of all documents/ pages etc. with their respective bids / proposals.
- 19. Contract for renovation works of OGRA's Regional Office Peshawar will be awarded to the bidder whose bid has been determined as most advantageous bid being substantially responsive and more relevant to the bidding documents/ requirements.
- 20. The successful Bidder is bound to carry out renovation works of OGRA's Regional Office Peshawar within given time period. In case of un-acceptable delay attributable to firm/general order supplier, OGRA will have the right to cancel the award of contract and forfeit the bidder's performance security/ bond.
- 21. The renovation works of OGRA's Regional Office Peshawar shall be monitored by OGRA's Regional Head sitting in Regional Office Peshawar and shall be rejected if not found according to the requirements of the tender documents; OGRA shall not be responsible for any costs or expenses incurred by the supplier on this account and no such claim for payment shall be entertained by OGRA.

- 22. The successful firm will provide standard' guaranty / warranty & free of cost, on site after completion of renovation works.
- 23. The OGRA reserves the right to change/modify goods specifications/ quantity at any time before the award of contract. OGRA may also accept or reject part or whole of the tender prior to the acceptance of the proposal.
- 24. The firm/ bidder will certify that they have read and completely understood the Tender Notice as well as the Terms & conditions of this Tender/ Bidding Documents including Criteria, Technical/ Pre-qualification & Financial Proposal etc. and hereby accept the same unconditionally.
- 25. The work/purchase order will be awarded on "Lump sum Rate basis" and not on item rate basis (aggregate of total financial proposal/bid).
- 26. Payment of the bills will be subject to deduction of all applicable government taxes/levies and subject to satisfactory completion of task/work, installation of items etc.
- 27. Any difference of opinion or disputes arising between the parties i.e. OGRA & the Successful Bidder in relation to this contract shall be settled amicably by the parties. In case of any difference/ dispute arising between the parties, the matter shall be referred to the Chairman, OGRA as Arbitrator, whose decision shall be final and binding upon both the parties. No dispute once decided by the Arbitrator shall be agitated at any forum including in any Court of Law.
- 28. In case, the last date of submission of bids falls on closed official day(s)/ holiday(s), the date for submission & opening of the bids shall be the next working day.
- 29. OGRA reserves the right to accept or reject any or all proposals or extend the closing date without assigning any reason as per PPRA Rules 2004.


