## **PUBLIC HEARING NOTICE**

# Public Hearing by the Authority to consider SNGPL and SSGCL's Petitions for amendment in Standard Gas/RLNG Supply Contracts for Domestic and Commercial Use

Government of Pakistan through its Inter-Ministerial Committee for Energy Conservation has decided that in order to save gas, conical baffle shall be added to geysers and the new geysers to be installed shall have conical baffles already placed in it.

In compliance of the directives of Federal Government, Sui Northern Gas Pipelines Limited and Sui Southern Gas Company (the petitioners) have requested the Authority for amendment in Standard Gas/RLNG Supply Contracts for Domestic and Commercial Use.

In view of above petitions, OGRA hereby invites all consumers, interveners, general public and interested/ affected persons and parties to furnish their comments/ interventions/ views, if any, on the subject petitions filed by the petitioners within 3 days from the date of publication of this notice or during the Public Hearing.

All interveners must indicate the manner in which they are likely to be affected. Intervention request should be accompanied by an affidavit verifying the contents of the intervention, intervention fee of Rs. 500/- (demand draft in favour of OGRA) and authority letter, if representing an organization/entity.
