

# PUBLIC HEARING NOTICE

## TO CONSIDER PETROSIN CNG PRIVATE LIMITED'S APPLICATION FOR GRANT OF LICENSE FOR STORAGE AND TRANSPORTATION OF CNG AND SALE OF NATURAL GAS (AT MARI HALINI FIELD)

Petrosin CNG Private Limited, Islamabad (the applicant) has applied under OGRAs' Natural Gas (Licencing) Rules, 2002 for the grant of license to carry out the regulated activity from Halini Well -X1 (Karak Block) located near Shakardara in District Mianwali, Punjab to its consumer i.e. Petrosin Edible Oil, Hattar, district Haripur.

The applicant has stated that they have entered into Halini Well-X1 (Karak Block) field low pressure **Gas Sale / Purchase Agreement** with Mari Petroleum Company Limited on **29-04-2022** subject to the availability of gas during the term of this Agreement for 02 MMCFD as produced from the Halini production facility at delivery point.

After fulfillment of the requisite data / information, the Authority after admitting the instant petition u/r 5 of NGRA (Licensing) Rules, 2002 conducted Public Hearing on 28-04-2021, however due to the retirement of one of the Hon'ble Authority Member, Public Hearing is conducted again.

All persons and parties who are likely to be affected by the grant of license are again informed to file objections, written statements or intervention request addressed to Registrar OGRA, describing the manner in which such persons shall be affected and may also appear on below mentioned hearing. The intervention requests shall be filed alongwith fee of Rs. 500/- (bank draft) and affidavit verifying the contents of communication on or before the date of Public Hearing as fixed by the Authority through this notice. Copies of the documents can be obtained on payment of prescribed charges of Rs.2/- per page from the office of the Registrar.
