NOTICE FOR PUBLIC COMMENTS / HEARING

APPLICATION FOR GRANT OF LICENCE BY GHAZI GAS MARKETING & DISTRIBUTION (PVT.) LIMITED, FOR SALE OF FLARE GAS FROM RAJIAN GAS FIELD (OGDCL) CHAKWAL

Ghazi Gas Marketing & Distribution (Private) Limited, (GGDPL) (the applicant) had applied under OGRA's Natural Gas Regulatory Authority (Licencing) Rules, 2002 for grant of license for Sale of Flare Gas /Natural Gas. GGDPL stated that they had successfully won the Rajian Oil Field Low Pressure Gas contract from OGDCL which was advertised by them on 20-06-2020 and subsequently bids were opened on 09-07-2020. In the same bid M/s Ghazi Gas Marketing & Distribution was declared as successful bidder. The applicant further elaborated its regulated activities that they will sell /distribute the Low-Pressure Natural Gas (Flare Gas) from Rajian Gas Field, Mogla Rajian Village, District Chakwal, Punjab to the consumers in the provinces of Punjab, Khyber Pakhtunkhwa and Federal Capital area Islamabad. The Flare Gas will be processed /filled either in skid tube containers or cascade cylinders mounted on the trailers and then it will be transported / supplied to nominated Industrial consumers.

After completion of the requisite data / information by the applicant, the Authority has admitted the instant application for Public Comments / Hearing under Rule (5) of Natural Gas Regulatory Authority (Licensing) Rules, 2002. Therefore, all persons and parties who are likely to be affected by grant of this license are hereby notified to file objections, written comments/suggestions and intervention requests within (15) days addressed to Senior Registrar OGRA, describing the manner in which such persons/parties may be affected by the grant of this licence and may also appear on the below mentioned Public Hearing.

The intervention request shall be filed alongwith fee of Rs. 500/- (bank draft) and affidavit verifying the contents of communication on or before the date of Public Hearing. Copies of the documents submitted by the applicant can be obtained on payment of prescribed charges of Rs. 2/- per page from the office of Registrar or can be downloaded from OGRA's website.
