- The bidder should submit the bid on the basis of a single stage one envelope procedure containing separately "Technical/Prequalification Proposal" (Annex-I) and "Financial Proposal" (Annex-II), both showing the Tender Enquiry No.06 of 2023,
- 2. The firm should be registered with Income Tax and Sales Tax Departments; Registration Numbers and NTN numbers should be clearly mentioned and valid documentary evidence be attached.
- 3. The bidder will be required to submit a Bid Security/earnest money equal to 3% of the total quoted value of bid and attach the same with Financial Proposal in the form of **Call Deposit** in favor of OGRA, payable at Islamabad.
- 4. The Successful Bidder should be required to deposit a "Performance Bond" equivalent to 5% of the total value of the quoted amount through a Call Deposit in favour of OGRA payable at Islamabad. If the bidder fails to deposit the Performance Bond within one week of the receipt of the Purchase/ Work Order, the same shall be treated as cancelled and 3% Earnest Money already deposited by the bidder shall be forfeited.
- 5. 3% earnest money of the un-successful bidders shall be released within 30 days. However, 5% Performance Bond shall be released after completion of task i.e. satisfactory shifting of office files/record, furniture/fixture & machinery & equipment and other misc. items/material etc. from existing OGRA building (54-B, Fazal-e-Haq Blue Area, Islamabad) to newly OGRA's constructed office building, located at Plot No. 37 & 39, Mauve Area, Sector G-10/4, Islamabad.
- 6. The firm should have a minimum of two (02) years' relevant experience and should have a well-equipped & maintained office set-up at Islamabad / Rawalpindi.
- 7. The bid validity period will be three (03) months, starting from the date of opening of bids. The rates quoted by the bidder are final & fixed and no inflation/ escalation in dollar against Pak rupees will be paid by OGRA and any increase in labour charges and transportation shall also not be borne by OGRA. No such claim from the bidder will be entertained.

Sealed bids/ proposals are required to be delivered at OGRA's Head Office, Plot No. 54-B, Fazal-ul-Haq Road, Blue Area, Islamabad latest by November 15, 2023 on or before **11:00 a.m.** Both the proposals i.e. technical/pre-qualification and financial proposals will be opened on the same date & time by OGRA's Bid Opening Committee at 11:30 i.e. on November 15, 2023 in the presence of bidders or their authorized representatives, who may like to be present.
- 9. Bids, which are not accompanied by the documents mentioned at Clause No. 2 & 3 shall be declared non-responsive.
- 10. The proposals should not have any over-writings or cutting. The bids with any of the aforementioned deficiencies may not be considered.
- 11. The firm should have to attach an undertaking that the firm has not been blacklisted by any Government, Semi-Govt., Autonomous body or any state-owned organization.
- 12. The successful bidder/ firm shall be bound to shift of office article, furniture, fixture and machinery/equipments etc. from existing Office building to OGRA office situated at Plot No. 37 & 39, OGRA Headquarter, Mauve Area, Sector G-10/4, Islamabad in a swift & safe manner.
- 13. Before submission of bids, all bidders are advised in their own interest to read carefully the terms & conditions of the tender documents and attach legible copies of all documents/ pages etc. with their respective bids / proposals.
- 14. It will be the sole responsibility of firm for any damage, theft, loss etc. of goods during shifting as well as any physical injury to any laborer during the shifting process shall solely be responsibility of the firm.
